Sub: Advisory for updation of mobile numbers of the electors (Registered Veterinary Practitioners) available in electoral roll for e-voting in Veterinary Council of India - members election 2020-reg.

The Central Government conducts the election of 11 members of the Veterinary Council of India under clause (g) of sub-section (3) of section 3 of the Indian Veterinary Council Act, 1984 as per the Indian Veterinary Council Rules, 1985 in exercise of the powers conferred by section 4 of the Indian Veterinary Council Act, 1984(52 of 1984).

The Veterinary Council of India prepared the electoral roll including the name, mobile numbers of every person whose name is entered in the IVPR after the notification in rule 3 of IVC Rules 1985 and published the draft electoral roll under rule 5 of the said rules by displaying in the offices of all State Veterinary Councils and the Veterinary Council of India. Under rule 6 of IVC Rules 1985, the Registered Veterinary Practitioners' throughout the country were given 15 days period from the date of publication of the electoral roll in draft to claim for inclusion and updation of their name, mobile number for the purpose of online VCI election.

The Veterinary Council of India published the final electoral roll for display at the offices of the State Veterinary Councils and Veterinary Council of India and sent the final electoral roll to the Central Government.

As per Rule 10 of the said rules, the dates for nomination/ withdrawal etc were finalized by the Returning Officer and the same was published in the Official Gazette of India on dated 29.06.2020.


Despite of systematically following all the rules, the Office of Returning Officer, VCI elections 2020 has received various representations from the Registered Veterinary Practitioners' throughout the country regarding the non availability/updation of mobile numbers in the electoral roll

Since, the participation of all the electors is of utmost importance in the voting process, the Returning Officer considered the said representations and has decided to grant a chance to the electors (Registered Veterinary Practitioner's) whose name is available in the electoral Roll to update

their mobile numbers to ensure that no voter is left behind from casting his/her vote in this first time e-voting of VCI elections in the country.

In view of the above, it is advised that the Registered Veterinary Practitioners' included in the electoral roll whose mobile numbers are not available or updated in the electoral roll may provide their mobile number (one only) in the format enclosed along with their scan copy of identity proof (Aadhar card/voter card/State veterinary Council id/ driving license) and email to vci-helpdesk@dahd.nic.in for the purpose of updating their mobile numbers by 15.07.2020. The numbers so compiled at the office of Returning officer will be sent to the State/UT Veterinary Councils/Veterinary Council of India for their updation in their records.

Kindly note that any such representation received after 15.07.2020, shall not be entertained in any circumstances.
